Right to Early Return Free of Charge

Delivery Valet

We perform the delivery of the leased vehicles to your address by using tow truck services following the completion of the order process within the scope of our Valet Delivery service.

We offer valet services when you cannot accept the delivery of the vehicle from the supplier since new vehicles are not street legal and delivery such vehicles using tow truck services.

Valet Return

We pick up the leased vehicles from the address you provided following the expiration of the agreement with our Valet Return service.

We pick up the leased vehicles from the address you specify with tow truck services if necessary, depending on the address you declared and the number of vehicles to be returned. So that we prevent you from wasting your time waiting at the vehicle return point.

Periodic Maintenance Valet

We provide valet services for the periodic maintenance procedures required to be carried out during the term of the agreement within the scope of the Periodic Maintenance Valet service.

We prevent you from wasting time and resources during the performance of operational processes such as delivering the vehicle to, waiting at and taking the vehicle back from the service.

Tire Valet

Tire Valet is a service we offer for the semiannual mounting/dismounting procedures of the winter tires and all-season tire replacements.

This service is only provided in Istanbul for the moment.






Inspection Valet
